Commitment to achieving Net Zero

Business Moves Group is committed to achieving Net Zero emissions by **2040**.

Emissions Footprint - Year 1 Baseline: Nov 2021 to Oct 2022

Baseline emissions are a record of the greenhouse gases that have been produced in the past and were produced prior to the introduction of any strategies to reduce emissions. Baseline emissions are the reference point against which emissions reduction can be measured.

Emissions Footprint - Year 2: Nov 2022 to Oct 2023

This is the second year of reporting where we have achieved an absolute reduction of 3.77% against scope 1 & 2. These achievements have been verified in line with the ISO14064, Carbon Reduce programme. GHG emissions for this year 724.16 tCO₂e.

Emissions Footprint - Year 3: Nov 2023 to Oct 2024

This is the third year of reporting, during which the criteria for Carbon Reduction certification have been achieved. The total greenhouse gas emissions recorded for this year stand at 940.58 tCO₂e.

Additional Details relating to Year 3 emissions calculations.

These emissions relate to energy use, electricity, natural gas, fuel use recycling and waste sent to landfill for the Group and have been calculated using the best available usage data.

Business travel - fuel usage refers to diesel used in our vehicle fleet and mileage records recorded by private car owners.

- Manage the logistics of our removal activities by considering the nearest geographical BMG region and planning work to meet the clients national, regional and local needs.
- Reduction in waste to landfill, add additional reporting using hierarchy of waste, resale, re-use, circular economy – donations to schools, hospitals etc.
